Describe architectural features. Evaluate the characteristics of this building in terms of other buildings in the community.

6 Conwell Street is a 2-story multi-bay inn, consisting of a front-gable roof section at the north end, and side gable additions toward the south. Brick chimneys near ridge of each building section; large shed wall dormer in north roof slope. Entry door locations altered on east façade; the only entrance remaining on former main (east) façade consists of a pane and panel door with storm. The rear (west) façade contains multiple entries at 1st and 2nd stories; wood stairs and 2nd story deck. Windows are mostly 6/1 replacement vinyl DHS; one multi-bay fixed window with leaded fanlight; 1/1 DHS in north façade; 1/1 and 6/6 replacement DHS on the rear.
