1 1/2-story, 4-bay; the cross-gable roof is clad in asphalt shingles; partial returns and corner boards encased in vinyl; exterior brick chimney on north end with terra cotta cap; pane and panel aluminum modern with wood storm, broken pediment entry hood supported by square brackets with wood porch deck, accessible on both sides (north and south); 6/1 vinyl surrounds; 1/1 vinyl; ; bow window with single-pane vinyl casements.
